1. World Alliance of Parsi Irani Zarthoshtis (WAPIZ) was registered by the Charity Commissioner, Greater Mumbai Region, Maharashtra State on 25th May 2005 and has since been granted exemption u/s 80G of the Income Tax Act, which was valid upto 31st March 2010 onwards vide circular No. 7/2010 (F. No. 197/21/2010-ITA-1) dated 27-10-2010.

#### 2. SIGNIFICANT ACCOUNTING POLICIES:-

System of Accounting:-

The Trust generally follows the accrual basis of accounting both as to income and expenditure except for those with significant uncertainties. Annual Fees are accounted on cash basis.

#### A) Revenue Recognition:-

- i. Founder Membership Fees and Life Membership fees are recognized as corpus of the trust in the year of receipt.
- ii. Ordinary membership fees are recognized as income during the year of receipt.

#### B) Fixed Assets:-

All the Fixed assets are stated at cost less depreciation

#### C) Depreciation:-

The Trust follows Written Down Value method of depreciation at the rates prescribed under the Income Tax Act, 1961.

3. Balance of cash on hand of Rs. 24,527.05/- at the year end is as per the certificate issued by the Manager of the Trust and the auditors have relied on the same.
